### Treasurer's Report

Stuart Heckman, Treasurer, reported that ACCI's financial position is strong. The final balance sheet for the 2017-18 FY was presented and distributed for inspection (posted on the ACCI Website <u>HERE</u>) as is the balance sheet as of the end of last month. The most recent audit was also posted. ACCI's restricted and reserve accounts are invested with Schwab and are earning at a reasonable rate.
